**MINUTES**

The Vice President Bob Cornwell introduced himself and the head table explaining that The President Dave Shavalier was away and he would be chairing the meeting. The attending members and guests then introduced themselves.

**GUEST SPEAKER**

Bob Cornwell introduced Brian Cook from Power Check, and Neil Mason a Loss Control Manager from I.N.G. Insurance Co. Brian went on to explain that his company was in the business of assessing primarily older homes for electrical safety and risk assessment. He noted that he was responding to an insurance industry perception that homes with knob and tube wiring and homes with 60 ampere services may represent a higher risk category. Brian reported that his company had assessed approximately 300 homes in the last year and all were found to require some remedial work. Neil responded that from an insurance industry viewpoint, at approximately 25 years old, some homes may have to be assessed. The industry would consider items such as roofs, hot water heaters, and electrical systems, as components that they would include. He also noted there was a feeling of comfort recognizing a third party assessment of older homes.

Bob Cornwell thanked both speakers and presented each with a gift as a token of appreciation.
